SEC Form 10-Q

Form 10-Q, sometimes listed as **QRTLYRPT** is a Security and Exchange Commission quarterly report filing form.

Form 10-Q shall be used for quarterly reports under Section 13 or 15(d) of the Securities Exchange Act of 1934 (15 U.S.C. 78m or 78o(d)), filed pursuant to Rule 13a-13 (17 CFR 240.13a-13) (https://ecfr.io/Title-17/se17.4.240_115d_613) or Rule 15d-13 (17 CFR 240.15d-13) (https://ecfr.io/Title-17/se17.4.240_113a_613). A quarterly report on this form pursuant to Rule 13a-13 or Rule 15d-13 shall be filed within the following period after the end of each of the first three fiscal quarters of each fiscal year, but no report need be filed for the fourth quarter of any fiscal year:

1. a. 40 days after the end of the fiscal quarter for large accelerated filers and accelerated filers (as defined in 17 CFR § 240.12b2) ;and
2. b. 45 days after the end of the fiscal quarter for all other registrants.

When a filing is a "Transition Report", it is filed as a 10-QT report (</Form/10-QT>). Amended quarterly reports are filed under form 10-Q/A (</Form/10-Q/A>). The latest Form 10-Q PDF can be found here (</Form/SEC-Form-10-Q.pdf>) (OMB Number: 3235-0070, Expires: July 31, 2021).
